Dear AK-500 CoC Applicants

Thank you to all organizations who submitted project applications to the Anchorage Continuum of Care (CoC). Attached is the final ranking of projects.

This year we received eight renewal applications, one for dedicated HMIS, one for CoC planning and a new bonus project. The amount requested by projects equals Anchorage's annual renewal demand.

Projects were ranked on overall project score and placed in Tiers. Higher scoring projects are ranked at the top. For this year's competition, HUD set Tier 1 at 93% of annual renewal demand and Tier 2 at 7% of annual renewal demand. CoC Planning Funds are not part of the either Tier 1 or 2. The Bonus Project was scored and is placed in Tier 2 as per NOFA instruction.
