



## Coordinated Entry Access Points

**Coordinated Entry (CE) is intended to quickly connect individuals experiencing homelessness to necessary resources.** CE is a federally mandated program that takes into consideration that communities rarely have enough resources in the community for all in need.

Its aim is threefold: to prioritize the most vulnerable; streamline the experience for both those requesting assistance and service providers; provide data, allowing for informed decisions.
